

Golfing Weekend in the hills of Emilia Romagna



Art and Flavours in a welcoming region in the heart of Italy
Valid from April 1st, 2004 through November 30th, 2004

Emilia Romagna has more golf courses than almost any other region in Italy. During this weekend golfing will take place on two of the best 18-hole courses in the region. Emilia Romagna is situated in an area full of art, nature and history famous for its cuisine, and inhabited by naturally generous and hospitable people. Apart from its wealth in important art cities, age-old towns, castles and luxurious dwellings, it is also the "**land of motors**" (Ferrari, Ducati, Lamborghini, Maserati, Bugatti), the "**land of flavours**" (Parmigiano Reggiano - parmesan cheese, Prosciutto di Parma - ham from Parma, Aceto Balsamico Tradizionale di Modena - traditional balsamic vinegar from Modena), the "**land of artists**" both historical and contemporary (musicians including Verdi, Toscanini, Pavarotti, Muti, Abbado; film greats including Fellini, Antognoni, Bertolucci; artists including Morandi and Guido Reni in addition to the writer Umberto Eco).

DAY 1 - Thursday

At 4 p.m., welcome drink at the 4-star hotel, only a few kilometres from Parma.
 Visit to a *ham factory* near Parma.
 Dinner at a restaurant in a Castle village.
 Return to the hotel.

DAY 2 - Friday

 Lunch at the Club House restaurant.
 Afternoon guided visit to the old town centre of Parma.
 Dinner at a typical *trattoria* in Parma.
 Return to the hotel.

DAY 3 - Saturday

Breakfast.
 Golf Club Modena.
 Lunch at the Club House restaurant.
 An afternoon visit to the *Ferrari* museum in Maranello.
 Visit and tasting at a vinegar producing company in Modena.
 Dinner at a restaurant in the old town centre of Modena.
 Return to the hotel.

DAY 4 - Sunday

Breakfast and departure.

THE PACKAGE TOUR INCLUDES :

- 3 nights in a double room at a 4-star hotel, continental breakfast.
- 2 green fees.
- Travel assistant (English).
- Tourist materials.
- All transfers that are mentioned in the text.
- Welcome drink
- All meals and beverages mentioned in the text.
- Guided visit to Parma and entrance fees to the monuments.
- Entrance fee to: a *ham factory*, a vinegar producing company and to the *Ferrari museum*.
- Mentioned tasting occasions.
- Medical insurance / luggage insurance.
- Tax and service percentage.

- Journey and transfer to the hotel
- Tips, luggage handling, personal extras and all items that are not included under "the package tour includes".

TOUR CONTRACT AND RESPONSIBILITY

The contracts connected to this program are in conformity with Italian law No. 1084 of December 27th, 1977 for the ratification and the execution of the International Agreement regarding travelling contracts (CVV) undersigned in Brussels on April 23rd, 1970. The responsibility of the travel organizer may never exceed the limits indicated in the law cited above.

PARTICIPANTS

The acceptance of payment depends on the availability of rooms and is effective upon the confirmation of the travel organizer.

PAYMENT

Upon registration, 25% of the participation fee must be paid for. The remaining amount must be paid one month before the departure date. If the departure date is less than one month away, then the entire participation fee must be paid for.

VALIDITY OF THE PARTICIPATION FEE

The fees are calculated according to the exchange rate on February 29th, 2004 and the carrier rates, which means that they may vary according to the variations of the exchange rate and the carrier rates. If the total cost increases more than 10%, the participant has the right to renounce his participation with an integral reimbursement of the amount already paid, on condition that the Organization receives a written note regarding this within 72 hours after having received information about the increase.

CANCELLATIONS

The participant may cancel his participation in the tour only by means of a registered letter or fax that must arrive at least 3 days before the departure date. The amount will be reimbursed to the participant, minus the following sum:

- 10% of the participation fee up to 30 working days before the departure date;
- 25% of the participation fee from 29 to 21 working days before the departure;
- 50% of the participation fee from 20 to 11 working days before the departure;
- 75% of the participation fee from 10 to 3 working days before the departure;
- 100% of the participation fee thereafter.

No reimbursement will be made to those who cannot leave due to the lack of or false travelling documents. No reimbursement will be made to anybody who does not show up for departure or cancels the tour once it has already begun. The participant may be substituted by another person, if the organizing company is informed about this at least 10 days before the departure date, in writing, and on condition that the person satisfy the particular requirements for the tour and that he satisfies all requirements necessary for the journey, without any problems regarding the passport, visas, etc. In this case, no amount will be debited to the participant.

CANCELLATION OF THE TOUR BY THE ORGANIZING COMPANY

The organizing company may annul the contract any time, in conformity with paragraph 10 of the Italian Law 1084 of the December 27th, 1977 concerning the International Agreement regarding travel contracts, without any other obligation than to reimburse the amounts that have been paid already. The organizer may also cancel the contract without any indemnity, if the minimum number of participants indicated in the program has not been reached, on condition that the participant has been informed about this at least 15 days before the departure date.

RESPONSIBILITY OF THE CARRIER

In any situation, the responsibility of the organizer is excluded in regards to all damages that the participant may complain about deriving from causes that do not depend upon himself or others but that influence the services indicated in the contract, i.e. incidents or acts of God. Neither the organizer nor others may be considered responsible for damages that derive from services supplied by a third party, outside the package tour and that derive from autonomous initiatives taken by the participant during the tour.

COMPETENT COURT

Only the Court of Bologna shall be the competent court for any controversies.
